The above sanction is subject to fulfillment of following conditions:-

- 1. The school will follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time.
- 2. The School is required to apply on online for further extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
- 3. The school will also abide by the conditions prescribed, if any, by the State Government concerned as mentioned in certificate as per appendix III issued by District Education Officer (DEO) /equivalent officer.
- The school should ensure the strong governance and management of its activities in way of comprehensive and quantifiable planning in way of curriculum planning, infrastructure, resources, physical education, staff development and other co-curricular areas.

 14. Every affiliated school shall sponsor regularly its bonafide and eligible students in Boards Class X and Class XII examinations from the year mentioned while granting affiliation/upgradation regularly without break or

Every affiliated school shall sponsor regularly its bonafide and eligible students in Boards Class XII examinations from the year mentioned while granting affiliation/upgradation regularly without break or inform with reasons thereof in writing well in time about the non-sponsoring of the candidates.
- 15. Running of **coaching institutions** in the school premises in the pretext of providing coaching to the students for various examinations is not permitted by the Board. Strict action would be taken on defaulters.
- 16. The Manager and the Principal of the school shall be jointly responsible for the authenticity of the online/offline documents/ information/data submitted by the School to the Board.
- Apart from rules to be adhered to by the school as mentioned above for drawing specific attention of the school authorities, the school authorities are required to acquaint themselves with all the rules contained in Affiliation & Examination Bye-laws and circulars/guidelines/ notification issued by the Board from time to time. Any laxity in following rules/instructions of the Board will lead to action against school as per Chapter 12 of Affiliation Bye-laws-2018.

- * The school has applied for recognition certificate in concerned department, hence, the school is required to submit copy of Recognition letter after obtaining from the concerned department.
- * The school has submitted land certificate with compactness for land area of 9472 sqmtr. However, as per IC and DEO certificate, the land area is 9914 sq mtr, hence, the school is required to submit clarification on variation of land area.
- * As per revised staff statement, the school has still not maintain section teacher ratio of 1:1.5, hence, the school is required to maintain the same and submit a copy of revised staff statement with showing Name, Qualification, Designation, Date of Appointment, Date of Confirmation etc.
- * The school is having high number of sections as per the norms of Affiliation Bye-laws. Hence, the school is required to restrict the sections as per norms stipulated in Appendix V of Affiliation Bye-laws and area reported & the sections shall not be increased by the school without specific approval of the Board.
